## 3. What the release allows

If authorised, H10 may capture, store, edit, reproduce and publish the camper's image and sound in the sporting, educational and recreational context of H10 Basquete Camp, in institutional and promotional materials — website, social media and other channels — for 24 months from the end of the camp, renewable. After that period, no new promotional use takes place.

## 4. Protections that always apply

- Images are captured only in collective sporting, educational or recreational settings. **Never** in dormitories, bathrooms, changing rooms or other private areas.
- We never publish information that identifies the child's routine outside the camp — home address, school or family routine.
- Images showing distress (crying, injury, discomfort or conflict) are never published publicly.
- No degrading use, no manipulation that changes the original meaning, no deepfakes, no paid transfer to third parties and **no training of third-party artificial intelligence models**.

## 5. Withdrawal

Withdrawal blocks any new use from the moment it is requested and removes active materials from H10 official channels within 30 days, where technically possible. It does not affect the lawfulness of previous use, nor material already published by third parties.

## 6. Photography for this edition

Photography is carried out by a specialised company contracted by H10 — for the January 2027 edition, **Ruas Mídia** (Brazilian company ID 37.377.978/0001-87) — which sells the photo archive directly to families. The gallery on the H10 platform is for viewing: the archive is not included in the camp fee, and any purchase is made with that company. The company is bound by the same limits set out in this document and does not publish or promote images of a camper without authorisation — which does not prevent the family from buying their own child's photos.

**How to buy the photos.** Ruas Mídia service line: **+55 11 91848-5585**. The purchase window runs from **15 October to 20 December 2026** — before the camp itself. Outside that window H10 neither intermediates nor answers for the sale.

**Face recognition is a separate decision.** To organise the gallery, the platform may automatically identify the camper's photos. That consent is given separately, on the platform; processing happens only on H10 infrastructure, never on a third-party service, and biometric data is deleted within 90 days of the end of the camp — or immediately upon withdrawal. Without it, the team identifies photos manually.
